Immediate goals are talk to the Sophomores and express the importance of the test. Work with Freshman to start following testing scores. Started Senior internship within the community and

have 6 students working with local businesses. 13 businesses available. Finals to present to class or board. Start a repore with businesses for internship to be available. Offset science with one offered every other year.

Elementary Principal Report:

Pre-K registration. 8 students in Pre-K Full day 8:30 to 3. We are identified as Targeted Support again. We are in year 2. We have made some gains but not enough to pull us out of Targeted Support. We have to be above 26.2 percentile. Data training was yesterday. Elementary newsletter just came out. We have a new communication system through PowerSchool that was tested today. Positive comments were made. Parents can be reached through email, tests and phone calls. Fifth and eighth grades will be going to the Norsk Hostefest Oct. Elementary will be setting a coffee kiosk with snacks. Parents can come in and fill up there thermos for 50 cents.
